Conditions of Lease

- 1. Rental rates: 6m = R650/month / 12m = R1300/month
- 2. A deposit of one (1) month's rental, and the first months rental is payable in advance. The deposit will be refunded on the first day of the month following the tenant vacating the unit.
- 3. All risk of damage, theft, loss or destruction of goods stored by the lessee remains with the lessee. The property of ISP Self Storage are entered and made use of at own risk. We shall not be held liable for any loss or damage to any stored goods.
- 4. Only the principle lessee as per the signed lease agreement will be able to enter the premises, and must therefore always be present when wanting to store or remove items from his/her unit. <u>Access to the</u> <u>premises will be suspended upon no payment by 2nd of every month.</u>

- 5. <u>No automotive engine parts, no flammable, explosive, harmful or</u> <u>unlawful goods may be stored</u>. The lessee shall be liable for any loss or damage caused to the property of ISP Selfstorage and/ or the property or person of the third party.
- 6. The lessee shall be responsible for their own secure lock and key to his/ her allocated unit.
- 7. Deposit refunds are subject to the tenant cleaning the unit after vacating.
- 8. <u>New tenants must provide legal proof of identity in the form of drivers</u> <u>licence or ID book for copy with application form.</u>
- 9. All rent shall be paid strictly in advance on the 1st day of each month. <u>Failure to comply with payment requirements will result in storage unit</u> <u>being locked, and a R300 penalty being levied</u>. Notice of one calendar month is required when terminating the lease agreement. No items shall be removed unless payment has been received in full.
- 10. In the event of the stored goods remaining in the rented unit after the paid-up lease period has expired, and no further agreement has been made, the lessee gives permission by being a signatory to the contract that the goods may be confiscated by ISP Self Storage and disposed of to cover loss of income suffered by ISP Self Storage. <u>ISP Self storage shall take such action after the lapse of 14 (fourteen) days after the paid-up lease period has expired.</u>
